TN NAFTA Recap. Mexican citizens are required to receive a visa in order to enter the U.S. as TN nonimmigrants. To apply for a TN visa as a Mexican citizen, contact the U.S. embassy or Mexican consulate. Conversely, Canadian citizens are eligible for entry (as nonimmigrants) without a visa.

A TN visa worker may apply for a new TN, file for a change of status, or otherwise make preparations to depart the U.S. during this grace period. Individuals cannot work during the grace period. A TN visa worker is eligible for this grace period during each period of his/her approved TN petition/application, i.e. one time for each TN status approval.
